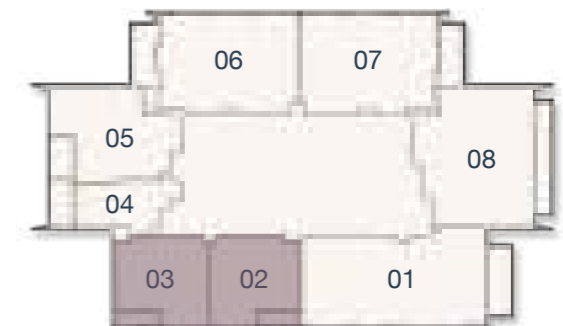
## 1 BEDROOM - TYPE A

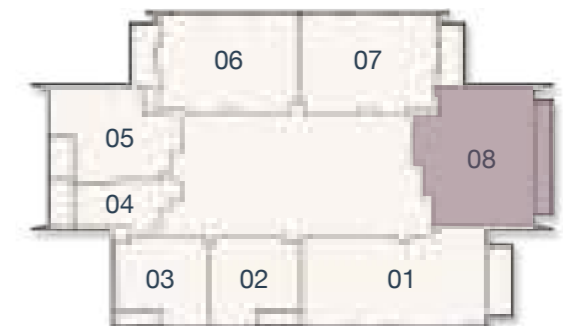
## 2 BEDROOM - TYPE B

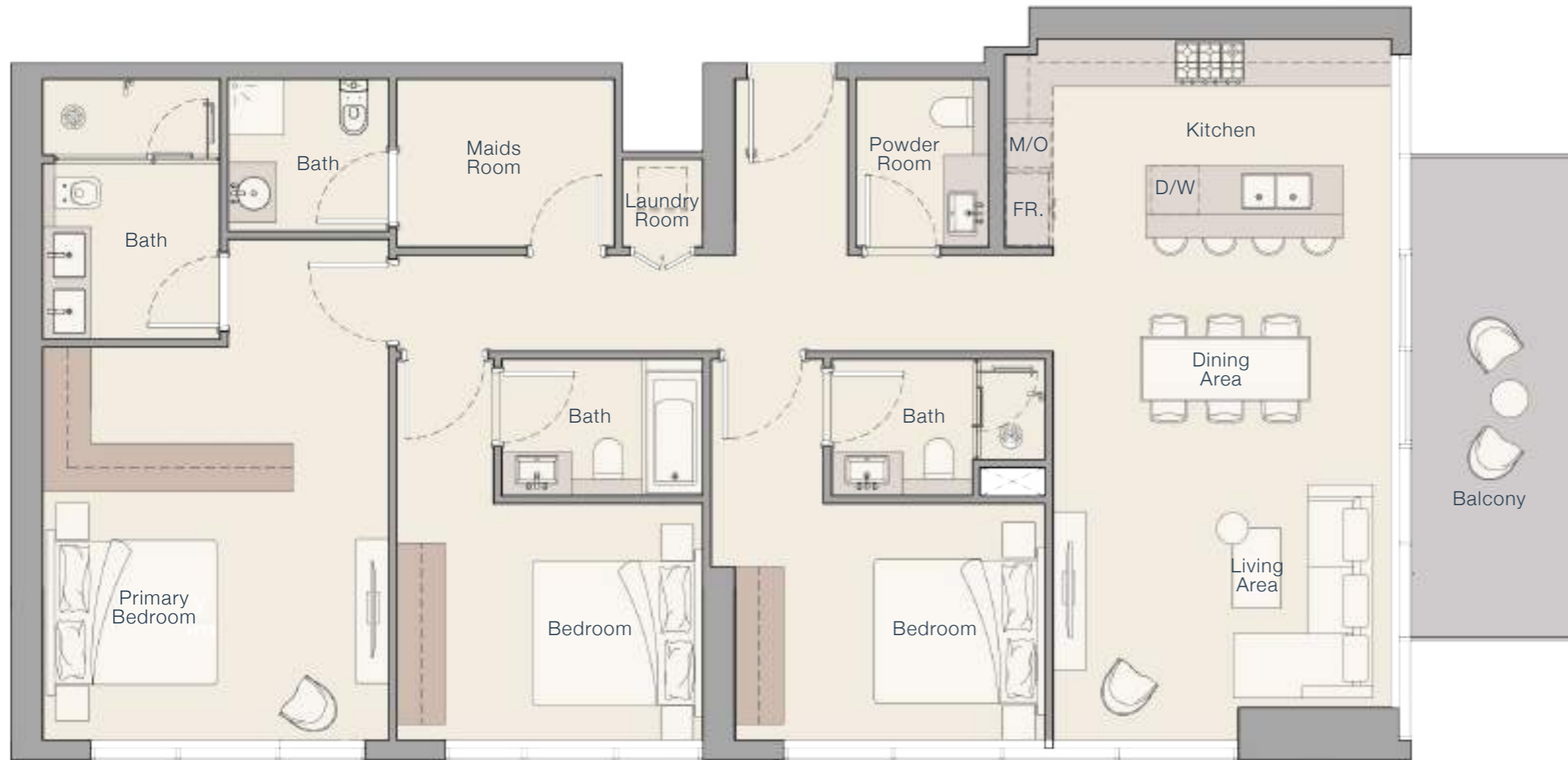

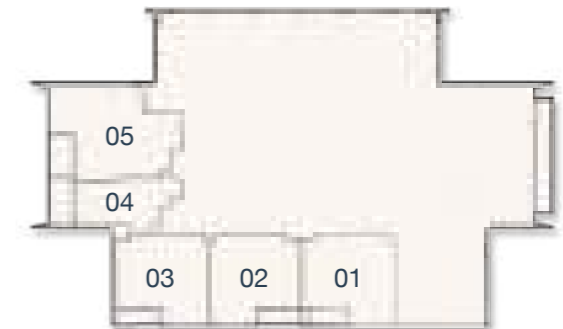

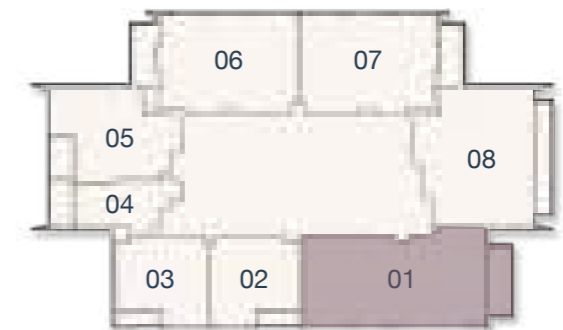
## 3 BEDROOM - TYPE A
